

## **Agreement on personal data processing**

Agreement on personal data processing (hereinafter — the Agreement) is the public offer.

Terms used in this Agreement:

The website is a set of the texts, graphical elements, design, images, program codes, photos and video content and other results of intellectual activities of the Website Administration containing in the Internet under the domain name “www.rosset-kzms.ru”

Administration of the Website is societies and persons which have administration rights on the Website.

The user is any person who visits the Website, fills fields of online forms on the Website and accepts terms of this agreement.

Personal data is the data provided by the User in Website online forms (name, e-mail address, phone number).

Processing of personal data is the list of actions executed with personal user’s information filled in online forms. Actions are as follows: collection, recording, systematization, accumulating, storage, refining (updating, changing), extraction, using, transferring (distribution, the access provision), depersonalization, blocking, removing, destruction of personal user information which sent a request, transfer upon the demand of court, including to the third persons, with observance of the measures providing personal data protection from unauthorized access.

1. Joining this agreement and leaving the data on the Website “<http://www.rosset-kzms.ru>”, (further — the Website) which belongs to JSC “Krasnokamsk Metal mesh Works” (further — JSC “KMMW”) by filling forms of online requests the User:

- confirms that all information filled in gaps personally belongs to him.
- confirms and acknowledges that he has studied the present Agreement and terms of his personal data processing by Website administration indicated by him in the fields of online applications carefully and in full scope, and that the text of the agreement and terms of his personal data processing are clear to him;
- agrees to process his personal data provided as a part of information by Website administration for the purpose of this agreement conclusion between him and Administration of the Website as well as its future execution;
- acknowledges terms and conditions of personal data processing without clauses and restrictions, namely with making by Administration of the Website the actions provided in c. 3 p.1 Art. 3 of the Federal law of 27.07.2006 N 152-FZ "About personal data" and as well as he confirms that giving such consent he acts freely, voluntarily and in their own interests.

2. The administration of the Website uses personal information of the user for:

- processing personal data which is necessary for provision and giving services to the User;
- creation, analysis and monitoring of client base;
- informing User about tenders and advertizing campaigns;
- sending newsletters of the Website to the User;
- informing User about new products and services;
- informing about promotions and special offers;
- notifying the User about various events.

3. The administration of the Website has the right to handle personal data by including them in electronic databases, in lists (registers) and internal forms of account. Processing of personal data can be both automated and without use of the automatization equipment.

4. The agreement is valid indefinitely from the time the User has submitted their data, and it can be called back by the User at any time by making by the User the relevant order or statement in writing on e-mail address: [office@rosset-kzms.ru](mailto:office@rosset-kzms.ru)

5. The Website administration has the right to amend this Agreement changes that are not inconsistent with applicable law. At insertion of changes the date of the last update is stated in the current reversion. The new edition of the Agreement enters into force upon its posting, unless otherwise provided in the new version of the Agreement.

7. To this Agreement and the relationship between the User and Website administration, resulting from the application of the Agreement shall be governed by the law of the Russian Federation.
